NB RENAISSANCE PORTFOLIO COMPANY SICIT WINS IL SOLE 24 ORE SUSTAINABILITY AWARD

- The award recognizes SICIT's leadership in sustainability and unique circular economy model

Milan, 4 November 2022 – NB Renaissance is delighted to announce that SICIT, an NB Renaissance Partners Fund III portfolio company, won *Il Sole 24 Ore*'s *Premio Impresa Sostenibile* (Sustainable Company Award), in the environmental sustainability category.

The award ceremony was held in the presence of Pope Francis at the Holy See. The Environmental Sustainability category included all innovations developed by SMEs with the aim of generating a positive impact on the environment.

The award selection process was extremely rigorous, and included a jury of senior leaders from *Piccola Industria Confindustria*, *Università di Roma "La Sapienza"*, *Gruppo 24 ORE*, the Vatican, and *Banco BPM*. Over 300 Italian companies applied for the award, and the jury chose the companies for which sustainability was key to overcome the difficulties in recent years and which could serve as a role model for building a more sustainable economy.

In its factories in Arzignano and Chiampo (near Vicenza, Italy), SICIT has pioneered a proprietary technology that transforms the residues from the leather tanning process into biostimulants for agriculture, retardants for the gypsum industry and biofuel. The company offers a strategic service for the tanning sector of the local Vicenza tanning district, reducing waste to almost zero without jeopardizing public health or the environment.

SICIT has always considered sustainability as a key competitive advantage and a driving force of its business. Throughout the years, Sicit has affirmed itself among the leading companies in the global chemical industry (top 2%) and the best globally in the segment of chemicals for agriculture.
